

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.accimm.com and Access Immigration LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Access Immigration LLC include www.accimm.com and Access Immigration. The Access Immigration website is a Law Firm site. By using the Access Immigration website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to provide you with services offered on our Site, Access Immigration may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) sending us a message; and (c) submitting your credit card or other payment information when ordering or paying for services on our Site. We will use your information for, but not limited to, communicating with you in relation to services you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Sharing Information with Third Parties

Tracking User Behavior
